## DISCLAIMER FOR FUND SPECIFIC RISK

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Standard Deviation:** The deviation of the return stream relative to its own average, based on monthly return data.

**Maximum Drawdown:** The maximum percentage decline over any period.
