The Long Beach Managed Prescient Fund is an actively managed portfolio which aims to provide real long-term growth in capital. The Fund invests in shares, bonds, cash, ETF's, listed real estate and derivatives, with up to 30% of the portfolio in foreign assets. The Fund is managed in accordance with Regulation 28.

Latest 1 year	28,24%	5,03%	In the recent US Senate run-offs in early January, the Democratic Party won two seats for a 50-50 split in the house, with vice-president Harris holding the tiebreaking vote. This gives Biden and the Democrats full control of the US government, and markets held some concern for what a Democrat agenda means for greater regulation, especially towards technology companies, and higher taxes. Control of both houses of congress, will give Biden the ability to undertake expansionary fiscal policy, and enact substantial COVID relief stimulus, and these positive benefits are likely to outweigh any concerns. The impact on corporates is likely to be higher revenue growth (stimulus) at reduced margins (regulation) and higher tax rates, but with a net positive for earnings growth. With the ongoing need for fiscal and monetary stimulus to repair the economic damage from COVID and associated lockdowns, equities which represent a claim on real assets and future earnings, remain attractive vs. global fixed income.

The global COVID health crisis remains ongoing at the start of 2021, with cases continuing to spread, and new more transmissible variants emerging in several countries including South Africa. Lockdowns are ongoing in the UK, and much of Europe is either in some form of lockdown or with restrictions in place to limit transmission. Vaccinations have started in the US and EU and developed market countries can be expected to significantly expand and accelerate their vaccination efforts. While the current lockdown restrictions can be expected to continue to suppress economic activity, with successful vaccinations campaigns, the potential end to the health crisis is also visible.

The Long Beach Managed Prescient Fund's offshore holdings continue to be invested in global equities. The fund's local holdings are largely invested in global and SA companies and Capital & Counties Properties in the UK, as well as SA and Australian property. The fund's portfolio is approximately equal weighted between companies which have benefitted from economic changes due to COVID, and companies which have been impacted by COVID. The fund maintains a preference for large capitalisation companies.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Standard Deviation: The deviation of the return stream relative to its own average, based on monthly return data.

Maximum Drawdown: The maximum percentage decline over any period.
