

LONG BEACH WORLDWIDE FLEXIBLE PRESCIENT FUND



INVESTMENT AND RETURN OBJECTIVE

The Long Beach Worldwide Flexible Prescient Fund is an actively managed portfolio which aims to provide real long-term growth in capital. Long Beach will select assets for the fund based on our proprietary research, and the fund's portfolio will generally be concentrated in between 20-30 individual holdings with a focus on global equities. The fund aims to be substantially invested in equities and may also invest in depository receipts, ETFs, property, bonds, commodities, derivatives and hold cash. The fund will invest on a worldwide basis in offshore and local markets.



PERFORMANCE AND RISK

In terms of South African Unit Trust regulations, due to the change to the fund's mandate, the fund may only publish performance data after one year, from 1 February 2022.

FUND COMMENT

With effect from 1 February, the Long Beach Flexible Prescient fund's name changed to the Long Beach Worldwide Flexible Prescient Fund, and the fund's investment mandate has changed to a Worldwide investment mandate.

The fund's ASISA classification has changed from South Africa Multi Asset Flexible to Worldwide Multi Asset Flexible. The fund's benchmark has changed from 75% FTSE JSE Shareholder Weighted All Share (SWIX) + 25% Cash (Stefi) to the ASISA Worldwide Multi Asset Flexible Sector Average.

Capital & Counties Properties (Capco) is the owner of the Covent Garden estate in central London, and holds a minority investment in Shaftsbury, which owns property in the West End adjacent to Covent Garden, and Lille Square. The fund has held a position in Capco for some time, and we continue to be optimistic on both the return prospects for Capco, and the portfolio diversification benefits of holding property. Capco's assets are prime real estate, in a major global city, with experiences and destination led usage, low debt levels, and trading at a discount to NAV.

The fund acquired a position in Capco after the share price had declined substantially on Brexit, and subsequently acquired additional shares on declines due to COVID. The economic impact of Brexit is likely to be much more nuanced than suggested by the universal negativity at the time. The UK's leading performance to date on vaccines is a clear positive, and the UK's ability to co-ordinate fiscal and monetary policy stimulus is also likely to have significant advantages vs. the EU post COVID.

In a world of unlimited monetary and fiscal stimulus, property as a real asset, offers inflation protection to long term investors. Capco is likely to benefit from both a more rational view of Brexit, and a post COVID recovery in economic activity. After almost two years of lock downs, stay at home orders, travel restrictions, live entertainment and dining out closures, Capco's unique position and estate is likely to benefit from significant pent-up consumer demand.

The Long Beach Worldwide Flexible Prescient Fund's holdings are invested in global equities and Capital & Counties Properties in the UK. The fund's portfolio is approximately equal weighted between companies which have benefitted from economic changes due to COVID, and companies which have been impacted by COVID. The fund maintains a preference for large capitalisation companies.

The portfolio has adhered to its investment policy objective as stated in the supplemental deed.

Maximum Drawdown: The maximum percentage decline over any period.
